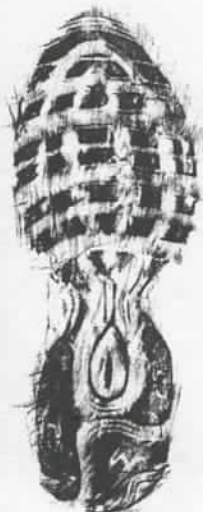

*How To Care For
Your
Never-Iron Shirt*

WASHING: On machines, use warm water setting and run for full cycle. By hand, use, warm (not hot) water. Rinse thoroughly but don't wring or twist.

DO NOT BLEACH.

AUTOMATIC DRYING: USE MEDIUM HEAT SETTING. Remove from dryer immediately after garment is completely dry.

DRIP-DRYING: REMOVE GARMENT from washer before spin cycle, or from tub after shaking out loose water. Hang and smooth out wrinkles. When dry, fold or hang neatly.

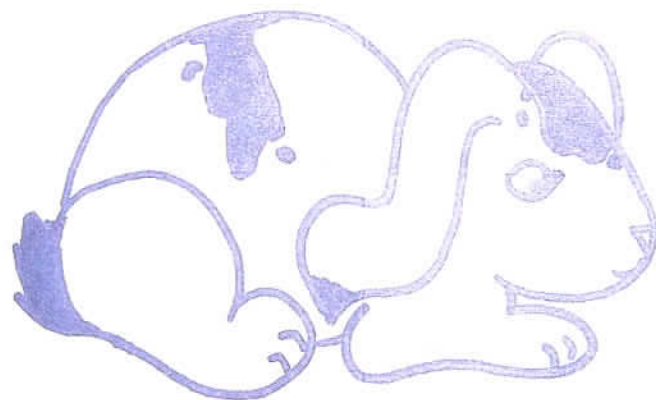

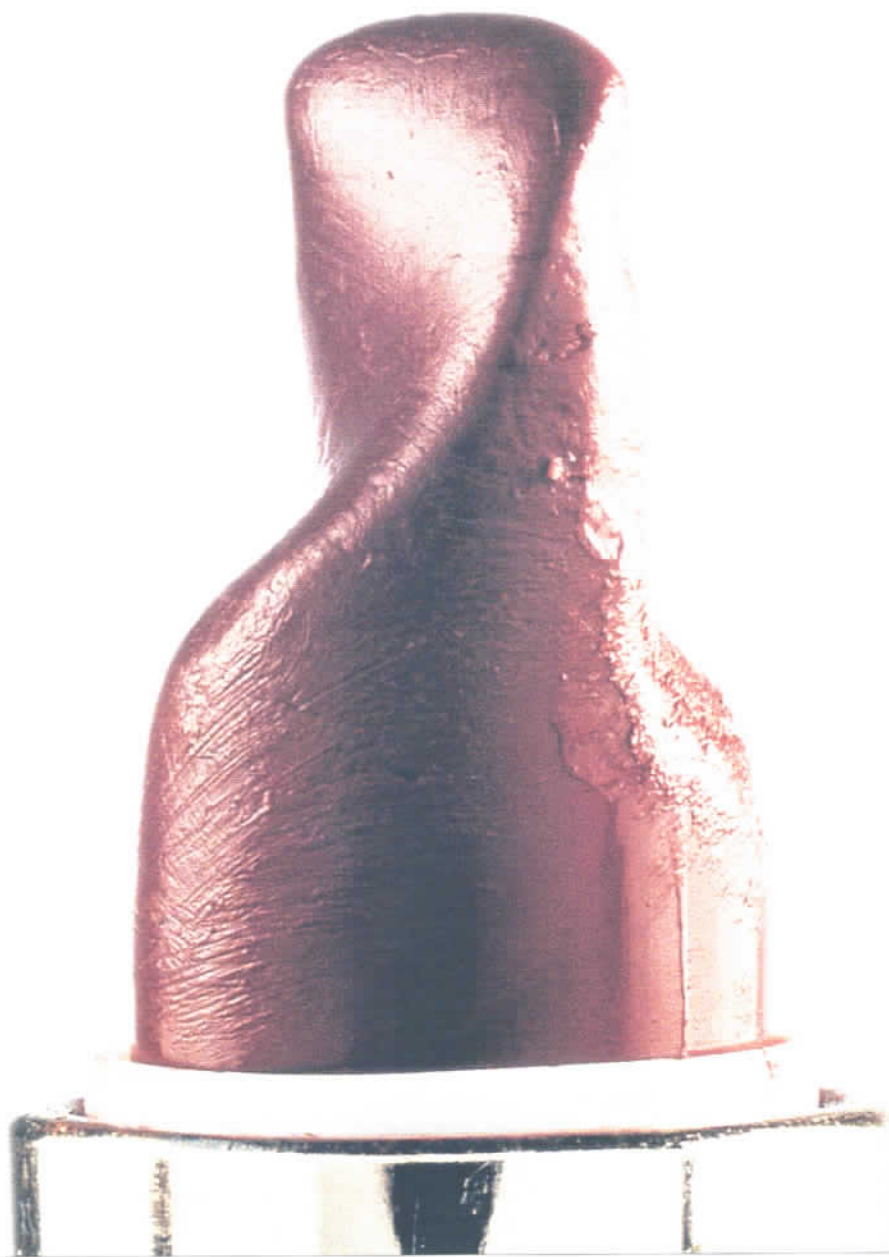

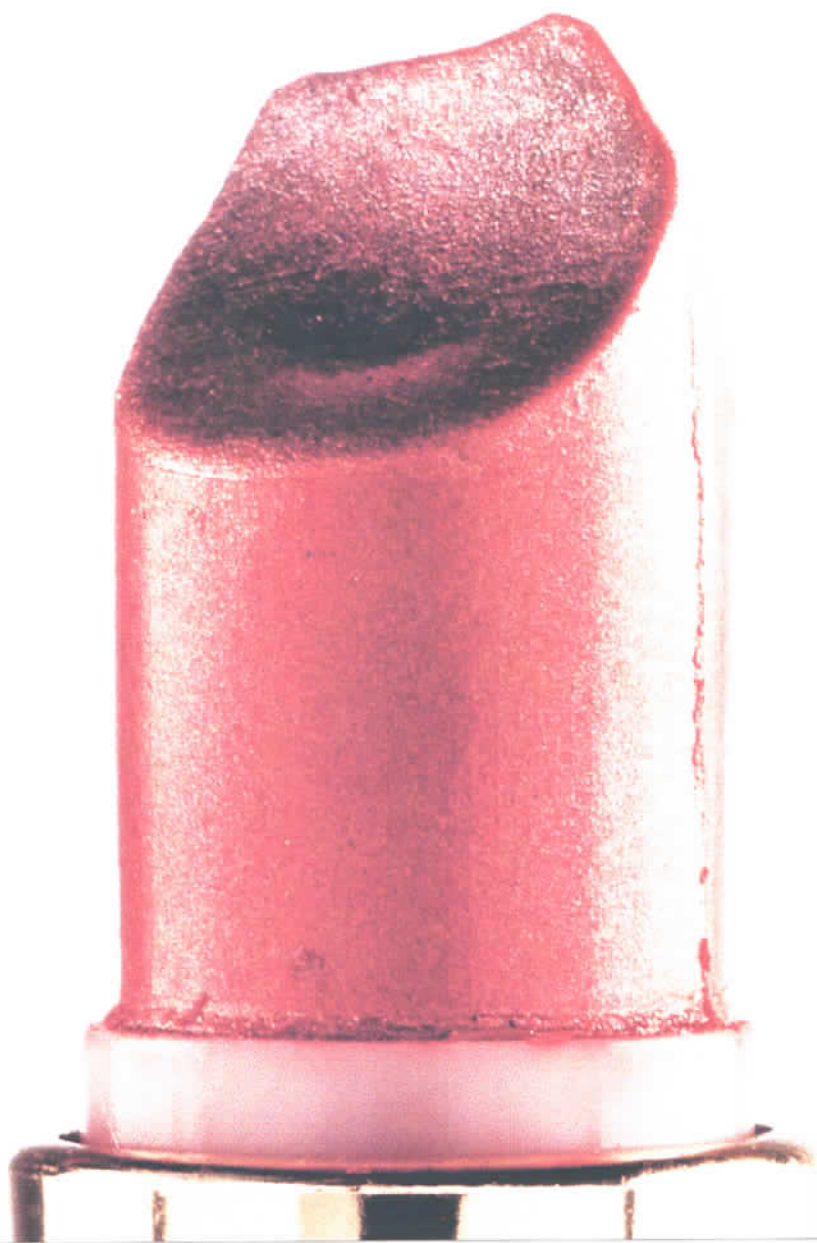
